Personal Injury

Most of his cases concern traumatic brain injury, often involving children, quadriplegia and paraplegia, multiple injuries and amputations. He frequently represents a high earning professional people. These cases often involve periodical payments orders.

Notable Personal Injury cases

Beall v Euro Construction Scaffolding Ltd

Industrial exposure to asbestos in the 1980s resulting in death.

Lynch v JHH Engineers Ltd et al

Fell off his own ladder but established liability subject to contributory negligence.

CB v British Cycling Federation

Brain damage caused by crashing during a cyclocross race.

Beveridge v Homan/Evans Transport Ltd

Brain damage caused by falling from a lorry during loading.

ESC v CCM

Carbon monoxide poisoning of a child at home in tenanted accommodation.

Beveridge v Homan/Evans Transport Ltd

Fell off a lorry during loading

Jones v Gavin Jones Ltd

When one of a tree cutting team, struck by a heavy branch when in the drop zone suffering head injury.

Seales v PIL Membranes Ltd

Struck by a metal bar at work causing a left carotid artery dissection resulting in a stroke.

Clinical Negligence & Healthcare

Notable Clinical Negligence & Healthcare cases

AB v Dr Handa

Failure to diagnose diabetes resulting in leg amputation of a child.

Stephens v Brighton and Sussex University Hospital NHS Trust

Surgical error in a craniotomy following aneurysmal subarachnoid haemorrhage which resulted in a ruptured aneurysm.

HXC v Lincolnshire Partnership NHS Foundation Trust

The claimant was a known suicide risk but the Defendants failed to take reasonable steps to prevent a suicide attempt resulting in the claimant suffering tetraplegia.
